

## Customer Reviews

First, this hasn't been updated in many years. The new "editions" just shuffle the same info. Second, the black letter "law" is from Model Business Corporation Act (MBCA). Less than half of states have adopted the MBCA and there are no signs that any more states plan to adopt it. On the other hand, your professor will teach (and your casebook will be based on) Delaware law. Why Delaware law? 75% of IPOs since 1975 have been in Delaware. 61% of fortune 500 corporations formed in Delaware. And over half of NYSE companies are in Delaware. The MBCA is irrelevant for law students, unless your professor teaches your state's law, which happens to have adopted the MBCA, which is highly unlikely. The E&E is a better choice.

Crunchtime for Corporations was incredibly helpful in my studying. I don't think I would have done as well on my exam without it. The outline and the sections on Securities Fraud were probably the most helpful. I would definitely recommend it, especially for someone who feels like they need to cram a little before their final.

This is a helpful overview of corporate law. I found the outline of derivative suits helpful. There was more in this book than we covered in class, yet the book is not too big to be overwhelming. It seems to be the perfect study aid size. I wish I had purchased it sooner.
